#### 2.1 Course Description:

Theory and concepts of financial accounting with particular emphasis on financial statements, revenue recognition, and current and long-term assets.

3 lecture hours, 0.5 course

Antirequisite(s): BUS 4417A/B

Prerequisite(s): Business Administration 2257 or MOS 2227A/B and enrolment in 3rd or 4th year of BMOS or Music Administrative Studies (MAS).

# 4. Course Objectives and Format

The DAN Department of Management and Organizational Studies as a whole draws upon an evidence-based management approach. Evidence-based management is the systematic process of gathering evidence from multiple sources, critically appraising the evidence, and using that evidence in making and evaluating management decisions to improve organizational performance.

#### 4.1 Course objectives

- 1. Understand the objective of financial reporting and the conceptual framework.
- 2. Prepare two financial statements- the Statement of Financial Position and the Statement of Comprehensive Income.
- 3. Properly account for the issues associated with revenue recognition.
- Assess the accounting issues associated with current and long-term assets in order to determine the appropriate approach for recognition, measurement, presentation and disclosure.

#### **4.2** Course format

*Class time:* Class time will consist of lectures, problem solving and discussion. Class discussion is expected so please be prepared for class.

Solutions: This course has a NO PHOTOS policy. Students are not permitted to take pictures of work done in class by the professors. Official solutions to the assignment problems will be made available on OWL after the relevant material is covered by all sections.

Self-Study Problems: Self-study problems will provide the student with the opportunity to practice the course material. The problems need not be submitted and will not be graded. The suggested solutions will be made available on OWL so that the students can check their own solutions and thereby determine their understanding of the material. The instructor should be consulted if the student has difficulty in understanding the suggested solution.

Assignment and Examinations: The assignment and examinations will test the student's comprehension of both the technical and conceptual aspects of the course.

Mastery of intermediate accounting concepts will require considerable time reading the textbook, CPA Handbook, and attempting assigned accounting problems. To perform well in this course, you must spend time completing accounting problems and checking the answers to test your understanding. To maximize your learning, you should make an honest attempt at the accounting problem before reviewing the solution. This is not a course to register in if you are seeking an easy credit. For many students, this course is a difficult one. The difficulty arises from a challenging subject matter as well as failing to devote enough time to the course content, including preparing for class, working through accounting problems, and completing the weekly assignments. You will find that there is likely to be a direct correlation between the number of accounting problems you prepare, the adequacy of your debrief of those problems, your attendance in class, your completion of the weekly assignments and your course grade.

#### 5.1 Professionalism

Professionalism will be assessed on a weekly basis according to the following rubric.

Level	Description.
0	Student is late for class, absent from class or attends class and <b>does not</b> demonstrate <b>professionalism</b> .
1	Student is engaged with the course materials throughout the class, demonstrates <b>professionalism</b> , but does not contribute to the discussion.
2	Student contributes by asking/ answering questions and making comments. Preparation for class is evident. Questions/comments are primarily factual in nature. Student demonstrates <b>professionalism</b> .
3	Student demonstrates good preparation for class, contributing content-based questions/ answers to both the lecture component <b>AND</b> the problem take up component. Offers insights and adds significant value to the discussion. Student demonstrates <b>professionalism</b> .

#### Professionalism is demonstrated in the following ways:

- 1. Arrive to class on time.
- 2. Use your electronic devices (ie. Laptop, tablet, etc.) for class purposes only. (Non class purposes include email, social media, non related news articles etc.)
- 3. Turn off your cell phone during class time.
- 4. Ensure your cell phone does not go off during class time.
- 5. Don't check your cell phone/electronic device messages during class time.
- 6. Attend class.

#### 5.2 Assignment

There will be one hand in assignment required for this course. The assignment will require you to research accounting issues using the CPA Handbook and analyze accounting data using Excel. It is due no later than 2:00pm on Thursday December 5, 2019.

You are permitted to work in a group of up to 3 students to complete the assignment. **Groups must consist of students who have the same instructor.** Only students that attend class regularly may complete the assignment as part of a group. Beware of working in groups and using material provided by other students without proper referencing- this will be considered cheating. **Plagiarism is a serious academic offence that can result in a penalty as severe as expulsion from the University.** Whenever you take an idea or a passage from another author, you must acknowledge your source by using quotation marks where appropriate, and by proper referencing such as footnotes and citations.

Assignments must be submitted using Word and Excel through the Assignment tab on the course OWL site so that Turn-It-In may be used to detect any plagiarism that may have occurred. As well, assignments must be submitted by hard copy to the drop box outside the MOS office on the 4th floor of the Social Science building. The drop box will be emptied at 2:00 PM on the due date. Any assignment delivered after the due date will be subject to a penalty of 5% for every 24-hour delay. Assignments not received by December 9, 2019 at 2PM will receive a grade of zero.

#### 5.3 WileyPLUS

All students must register with WileyPLUS at www.wileyplus.com/go/login in order to qualify for the adaptive practice and homework marks. Registration codes are included with the purchase of a new textbook (loose-leaf or e-copy options are available.)

Adaptive practice requires students to read the textbook chapter and answer questions **prior to** attending class. Homework questions are to be completed **after** class to enhance the student's understanding of the course content. Adaptive practice and homework questions are posted on WileyPLUS. The deadline for each adaptive practice and homework submission will be available in WileyPLUS and on OWL. The WileyPLUS adaptive practice and homework problems are an integral part of the learning process in this course, and are intended to supplement the lectures and in-class problems.

#### 5.4 Examinations

Exams may consist of a combination of multiple choice, long-answer problems and writtenresponse questions.

All exams are closed book examinations. Dictionaries are NOT allowed into the examinations. Only non-programmable calculators will be allowed into the exams. If you are unsure, please ask your professor to check your calculator.

Electronic devices of <u>any</u> kind (including pagers, cell phones, tablets, smart watches and programmable calculators) are NOT permitted at exams.

Students are responsible for material covered in the lectures as well as the assigned chapters/sections in the text. Exams and assignments will not be returned to students but may be reviewed in the instructor's office.

Students are REQUIRED TO COMPLETE ALL COMPONENTS (assignment, mid-term, professionalism, WileyPLUS adaptive practice/ homework and final exam) of this course. There are no exceptions to this. Extra assignments to improve grades will NOT be allowed. Students MUST PASS the final exam in order to pass the course.

Exams will be scored using the program Scan Exam which examines the answer sheets for unusual coincidences in the pattern of answers given which may be indicative and used as supporting evidence of cheating.

Grades <u>will not be adjusted</u> on the basis of need. It is important to monitor your performance in the course. Remember: *You* are responsible for your grades in this course.

The DAN Department has a grade policy which states that for courses in the 3000 range, the class average must fall between 70% and 77% for all sections of a course taught by the same instructor. In very exceptional circumstances only, class averages outside this range may be approved by the Undergraduate Chair or Chair. Class averages are not grounds for appeal.

Students are <u>not</u> permitted to record any portion of a class, audio or video, without the prior written permission of the professor.

Lectures and course materials, including power point presentations, outlines, and similar materials, are protected by copyright. You may take notes and make copies of course materials for your own educational use. You may <u>not</u> record lectures, reproduce (or allow others to reproduce), post or distribute lecture notes, wiki material, and other course materials publicly and/or for commercial purposes without the written consent of the Professor.

#### 8. Exam Policies

- Nothing is to be on/at one's desk during an exam except a pencil, an eraser, a non-programmable calculator (not in the sleeve) and the individual's student card.

#### 9.2 Subject Line Must Include Course and Section Number

The subject line of emails must contain the name or number of the course, and the section number in which the student is enrolled. The Professor teaches different courses and sections and cannot properly respond to questions if he/she does not know which course or section you are enrolled in.

#### 9.3 Acceptable Emails

#### 9.4 Unacceptable Emails

#### 10. Attendance

It is expected that students will attend all classes. The professor does not provide access to lecture notes. Students are encouraged to obtain missed lecture notes from a fellow student.

#### **10.1** Short Absences.

If you miss a class due to minor illness or other problems, check your course outlines for information regarding attendance requirements and make sure you are not missing a test or exam. Cover any readings and arrange to borrow the missed lectures notes from a classmate.

#### 10.2 Extended Absences.

If you are absent more than approximately two weeks or if you get too far behind to catch up, you should consider reducing your workload by dropping one or more courses. The <u>Academic Counsellors</u> can help you to consider the alternatives. At your request, they can also keep your instructors informed about your difficulties.

#### 11. Grade Fairness

Fairness requires that all students be treated equally and be evaluated using the criteria set out in this course outline. The evaluation criteria are based on actual achievement and not on how hard a student has tried.

Claims by students of an excellent academic history, good attendance record, need to obtain or maintain a scholarship, desire to be admitted to Ivey or graduate school, or other personal issues, cannot be used to justify a higher grade in the course or a reweighting of course components. There is no extra work or assignments available for extra credit or to "make up" for a course component that was missed or performed poorly.

### 12. Posting of Grades

Midterm exam grades will be posted on OWL once the grades are available. Final exam grades and final course grades are not posted on OWL and are available once they have been posted by the Registrar under "Academic Summary" at the <u>Student Centre</u> website.

Students who experience an extenuating circumstance (illness, injury, or other extenuating circumstance) sufficiently significant to temporarily render them unable to meet academic requirements may submit a request for academic consideration through the following routes:

- Submitting a Self-Reported Absence form provided that the conditions for submission are met (maximum of 2 from September to April, valid for 48 hours or less, on course work worth less than or equal to 30%); or
- ii. For medical absences, submitting a Student Medical Certificate (SMC):

  signed by a licensed medical or mental health practitioner in order to be eligible for Academic Consideration: or
- iii. For non-medical absences, submitting appropriate documentation (e.g., obituary, police report, accident report, court order, etc.) to Academic Counselling in order to be eligible for academic consideration. Students are encouraged to contact their Academic Counselling unit to clarify what documentation is appropriate.

Students seeking academic consideration:

- are advised to consider carefully the implications of postponing tests or midterm exams or delaying handing in work;
- are encouraged to make appropriate decisions based on their specific circumstances, recognizing that minor ailments (upset stomach) or upsets (argument with a friend) are not an appropriate basis for a self-reported absence;

must communicate with their instructors no later than 24 hours after the end of the
period covered by either the self-reported absence or SMC, or immediately upon their
return following a documented absence.

#### **13.2** Make Up Examinations

The student must write a make-up exam if the regularly scheduled exam is missed for reasons for which adequate documentation is received by the instructor (this documentation must be supplied by the Academic Counseling office).

The date and time of the make-up examination will be set by the instructor, who will communicate the date to the student.

If a student is unable to meet the scheduled make-up as agreed, then the student is responsible for obtaining new accommodations from Academic Counselling, and seeking a new make-up date with the instructor within a reasonable time frame.

### 14. University Policy on Cheating and Academic Misconduct

Students are responsible for understanding the nature of and avoiding the occurrence of plagiarism and other academic offenses. Students are urged to read the section on Scholastic Offenses in the <u>Academic Calendar</u>. Note that such offenses include plagiarism, cheating on an examination, submitting false or fraudulent assignments or credentials, impersonating a candidate, or submitting for credit in any course without the knowledge and approval of the instructor to whom it is submitted, any academic work for which credit has previously been obtained or is being sought in another course in the University or elsewhere. If you are in doubt about whether what you are doing is inappropriate, consult your instructor. A claim that "you didn't know it was wrong" will not be accepted as an excuse.

Cheating on exams will not be tolerated; students are referred to the university policy on scholastic offenses. Looking at the test of another student, allowing another student to view your exam, or obtaining information about a test in advance are all examples of cheating.

Students found cheating will receive a zero (0%) on that exam. A number of safeguards will be employed to discourage cheating. For example, examination supervisors (proctors) of the tests may ask students to move to another seat during the exam, cover their paper, avert their eyes from other students' papers, remove baseball caps, etc. This is not meant as a personal affront nor as an accusation of cheating, rather as vigilant attempts at proctoring.

The penalties for a student guilty of a scholastic offense include refusal of a passing grade in the assignment, refusal of a passing grade in the course, suspension from the University, and expulsion from the University.

# 15. Procedures For Appealing Academic Evaluations

- 1. In the first instance, all appeals of a grade must be made to the course instructor (informal consultation).
- 2. If the student is not satisfied with the decision of the course instructor, a written appeal must be sent to the Undergraduate Chair: Student Affairs of the Department of Management and Organizational Studies.
- 3. If the response of the Undergraduate Chair is considered unsatisfactory to the student, he/she may then appeal to the Dean of the Faculty in which the course of program was taken.
- 4. Only after receiving a final decision from the Dean may a student appeal to the Senate Review Board Academic. A Guide to Appeals is available from the <u>Ombudsperson's Office</u>.
